RESULTS AND DIVIDENDS

REVIEW OF THE BUSINESS

The company's principle activity during the year was that of dealing with the maintenance of 19 Westbury Road.

DIRECTORS RESPONSIBILITIES

The Directors are responsible for keeping proper accounting records which disclose with reasonable accuracy at any time the financial position of the company and to enable them to ensure the financial statements comply with the Companies Act 1985. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.


