### Directors Report

In submitting the accounts for the year ended 31st March, 2004, the Directors report as follows:-

#### Statement of Director's responsibilities

Company Law requires the Directors to prepare financial statements for each financial year which give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period. In preparing those financial statements, the directors are required to:

There was a surplus of £289 (previous year – surplus £175) for the year, which has been transferred to the Maintenance Fund.


