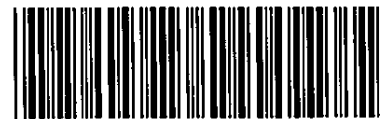

on the unaudited accounts of St. Edmund's Hall (Management Company) Kingsbridge Limited**




