

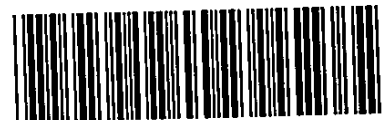

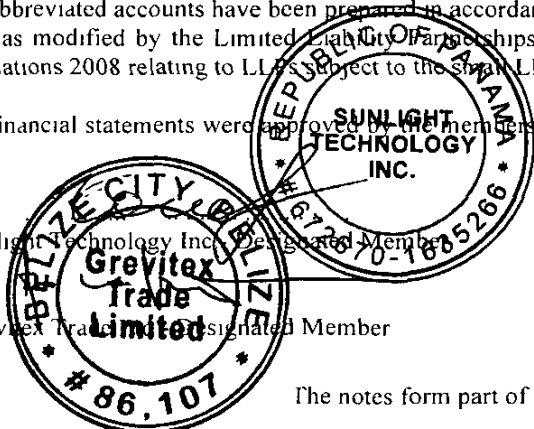

I ACCOUNTING POLICIES

Accounting convention
