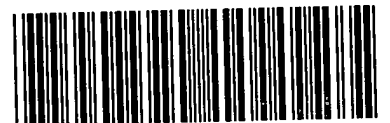



The director acknowledges his responsibility for ensuring that the company keeps accounting records, and preparing accounts that give a true and fair view of the state of affairs of the company of the financial year.


