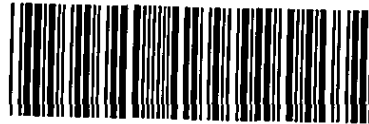

## 1 ACTIVITY

The principal activity of the company continued to be the management of the properties known as 24 Charles Street and 23A Hays Mews, London, W1 on a non-profit making basis

## 2 SHARE CAPITAL

The company is limited by guarantee and does not have a share capital. The members have undertaken to contribute a maximum of £1 each in the event of a winding up

## 3 FINANCIAL

The deficit for the year amounted to £1952. In accordance with the leases applicable to these properties, deficits are recoverable from tenants in future years and likewise, surpluses are refunded to tenants by reducing service charges. Accordingly no dividend is payable

## 5 STATEMENT OF DIRECTORS' RESPONSIBILITIES


## 6. STATEMENT OF DISCLOSURE OF INFORMATION TO AUDITORS

### 24 CHARLES STREET LIMITED
